### ENROLMENT APPLICATION

Candidates shall apply for enrolment by **completing and submitting an electronic application via the eVŠ portal <http://portal.evs.gov.si/prijava/>. They shall also submit all the required enclosures and supporting documents to the application electronically.** The website mentioned above also provides more detailed instructions on how to complete the enrolment application; the candidates shall get detailed information on the evidence required to apply for enrolment, and the recognition of education to continue the education when applying in the eVŠ information system.

The application completed and submitted via the [eVŠ portal](#) by the application deadline is **considered to be a timely application.**



Remember to resubmit your application if you have edited it after submission. If the application has been electronically signed and submitted, its status is "Signed with a certificate".

If you cancel the eVŠ application, it will be considered as an unsubmitted application.

### DEADLINES FOR THE APPLICATION SUBMISSION

Candidates for enrolment are required to submit **the application for the enrolment** in the first year of the Doctoral programme Teacher Education and Educational Sciences **no later than 2 September 2024.**

The deadline for meeting the entry requirements and to submit supporting documents is **13 September 2024.**

The candidate shall notify the Office of any data change; he/she shall immediately notify the Office **in writing of any withdrawal from the enrolment application.**

### EVIDENCE OF COMPLIANCE WITH THE ENROLMENT REQUIREMENTS

Scanned documents or photographs of the original certificates and other required documents and enclosures shall be considered as evidence of compliance with the enrolment requirements. Candidates will be notified of the request to complete the enrolment by e-mail provided in the application on the portal eVŠ.

#### ENROLLMENT LIMITATION AND SELECTIVE SUBJECT EXAMINATION

In case the number of applicants exceeds the number of available study places, a resolution on limiting enrolment will be adopted and published on the website of the Faculty of Education of the University of Ljubljana.

In the event of limited enrolment, the **selective subject examination will take place on 20 September 2024**. The candidates not taking the selective subject examination shall participate in the selection process but shall be awarded zero (0) points for the selective subject examination.

Enrolment of the accepted candidates will be completed no later than **30 September 2024**.

#### TUITION FEE

Tuition fee for the Doctoral programme (4 years) shall be EUR 12,000.00 (EUR 3,000.00 per academic year).

The student shall pay the tuition fee for each year in 3 instalments:  
- 10 % (300.00 EUR) upon enrolment,

- 45 % (1,350.00 EUR) no later than 30. 12. 2024,
- 45 % (1,350.00 EUR) no later than 28. 2. 2025.

After enrolment, the student shall receive the invoices in PDF format to his/her email address.

Candidates with foreign education certificates proving the fulfilment of the enrolment requirements shall submit, together with the enrolment application via the information system eVŠ, the application for the recognition of foreign education to continue studies at the University of Ljubljana, and all the required supporting documents and enclosures.

Only the applications for recognizing foreign education submitted in the information system eVŠ by the end of the application deadline **on 2 September 2024** will be considered in the procedures.
